EU Regulation 650/2012 on successions, which is applicable from the 17<sup>th</sup> of August 2015, will bring very important changes to the law of international successions in France, and in most European countries, but not in the United Kingdom which decided to opt out of the regulation.

What are the consequences of this regulation on successions split between France and England?

Will the current difficulties remain? How to respond to the new questions raised by the application of this regulation?
